



Farmland preservation victory in Pope Valley!

On June 2nd, the Board of Supervisors voted 3-2 (Luce & Dodd opposing) to uphold the Planning Commission's denial of the Lake Luciana development project in Pope Valley. Many thanks to California Farm Bureau Federation (CFBF) attorney John Weech for assisting with this major victory for ag preservation! John submitted a compelling letter and testified on our behalf on the key points of consistency with the county's General Plan and zoning laws.

Supervisors Diane Dillon, Keith Caldwell and Brad Wagenknecht voiced strong support for our county's ag protections and are to be commended for their votes in the face of enormous political pressure from the developers. Their decision to deny the project and prevent conversion of 200 acres of farmland to a private golf course reinforces our county leaders' commitment to agriculture as the immovable foundation for sound decision-making within Napa County.

USDA Offers \$10.9 Million to Help Reduce Air Quality Emissions - Deadline is June 26, 2009

Funds are now available to farmers and ranchers interested in reducing air quality emissions from off-road mobile or stationary agricultural sources. Applications will be accepted until June 26, 2009 for funds made available under a new air quality provision of the 2008 federal Farm Bill.

The funding, \$10.9 million, is being administered by the USDA's National Resources Conservation Service (NRCS) and is a new feature of the Environmental Quality Incentives Program (EQIP).
