



## **Voters approve 50 year extension of Measure J!**

County voters overwhelmingly passed Measure P on election day, securing a 50 year extension of Measure J, Napa's successful landmark farmland and watershed protection initiative. The measure preserves agriculture by allowing citizens to vote on development proposals which would convert ag land to a non-ag use. It also protects the 160 acre minimum parcel size for lands designated Ag Watershed & Open Space in the County's General Plan.

There was no vocal opposition to the initiative and broad support from the business and environmental sectors, city and county governments and a diverse array of citizens. Congratulations to the many volunteers of the Save Measure J campaign committee and to Committee Chairperson Volker Eisele for a job well done. We're very grateful for the community's support to protect Napa's legacy!

## **Putah Creek Watershed Group approves 2008/09 Water Quality Monitoring Plan**

The Steering Committee for the Putah Creek Watershed Group (PCWG) met on Oct. 27<sup>th</sup> and approved the Water Quality Monitoring Plan for the upcoming year. An assessment of \$5 per acre was set and participants will soon be receiving their invoices and a PCWG Status report.

Now in its 6<sup>th</sup> year, the Putah Creek Watershed Group is a voluntary coalition of growers who manage an ag water quality program. The program provides a cost effective way for growers to comply with mandatory water quality rules from the Central Valley Regional Water Board. Greg Rodeno serves as Chairman and Sally Kimsey is the Treasurer. Farm Bureau provides administrative support to the group. If you have irrigated ag land in the Putah Creek Watershed, and are not in the group, please contact Farm Bureau.

### In Stream Flow Policy – Observers wanted

As part of our efforts on creating a feasible water policy, we are hoping that you will engage in an experiment. We are requesting that you look at your creek at an easy to mark site like a bridge or where ever is easiest during and after the storms and write down the date and time of your observation along with the flow level on a form. This is simple but very effective way to document how many inches of rain over what period of time it took this winter to result in connected flow in different areas and how long that flow lasted.
